UPON hearing counsel for the Claimant and upon the Defendants not appearing

AND UPON the Claimant undertaking to comply with any order the Court may make if this order has caused loss to the Defendants, and the Court decides that the Defendants should be compensated for that loss

**PENAL NOTICE**

**IF YOU DO NOT COMPLY WITH THIS ORDER YOU MAY BE HELD TO BE IN CONTEMPT OF COURT AND IMPRISONED OR FINED OR HAVE YOUR ASSETS SEIZED**

It is ordered that:

- (1) the Defendants, by their servants agents or otherwise, be restrained from causing or permitting the further deposit of hardcore or other materials on upon the land marked upon the Plan annexed to this order ('the land');
- (2) the Defendants, by their servants agents or otherwise, be restrained from causing or permitting the further lopping chopping or removal of trees and hedgerows from the said land;
- (3) the Defendants, by their servants agents or otherwise, be restrained from causing or permitting entry onto the land of any caravans, touring caravans or mobile homes;
- (4) the Defendants, by their servants agents or otherwise, be restrained from causing or permitting the use of any caravans, touring caravans or mobile homes currently present on the said land
- (5) the Defendants, by their servants agents or otherwise, be restrained from causing or permitting the taking of any steps in the construction of any day room and use thereof

- (6) Service of this order shall be effected by service of Defendants (1, 2 and 3 and 5 ) on the said land and by the service of the Fourth Defendant Care of Mr Harwood at Sunnyside, Reading Road, Blackwater, Hants GU17 OBD. Service to be initially effected by service of a PDF copy of this order. Thereafter the Claimant shall serve the original Order upon the aforementioned Defendants as soon as reasonably practicable.
- (7) Costs of this application are reserved;
- (8) Liberty to the Defendants to apply on 48 hours notice in writing.
